



Dear WAEA Members;

I hope everyone is having a great fall. It is an honor and privilege to serve as your WAEA President. This is my first newsletter column and there are a number of things to be shared with you. First, a big thank you to everyone who attended the meetings in Hawaii. We had 124 people in attendance plus a large number of spouses and guests which was great to see. Thank you to everyone who served on the review and award committees.

The biggest responsibility for the President is organizing the annual meeting which will be held jointly with the AAEA in Denver in 2010. As I discussed last year and again this year, our WAEA program will be a one day event on Tuesday, July 27<sup>th</sup>. There will be no WAEA specific selected paper sessions as AAEA will have ample selected paper and poster sessions. The past two times we had a joint meeting with AAEA, attendance was poor at the WAEA selected papers. Consequently, we are trying something new this year.

We are going to ask for nominations from WAEA

departments for distinguished alumni who work in industry (outside academia). The alumni must have earned a graduate degree in agricultural or resource economics and be involved in a senior level position in their respective organization. Criteria will be sent to each council representative who can work with their unit leader to identify a suitable candidate. This is strictly voluntary as there is no requirement that each program have a nominee.

The alumni will be invited to attend the WAEA meeting and participate in a series of symposia that will be held in lieu of our selected papers. The topics for each alumnus will be arranged with the WAEA council member, department head, the alumnus, and myself. Each department will probably have their own way to determine their nominee but if you think of suitable candidates, please visit with your WAEA council member whose name can be found on the WAEA website ([www.waeaonline.org](http://www.waeaonline.org)).

We will have these individuals identified by November 1 so that we can coordinate with AAEA sections (AEM, TLC,

GSS, and FAMPS have asked to sponsor a session with us). In addition, we want to make sure and get the date on each alumnus' calendar.

Over the next year we will be working with the executive committee to bring a budget and discussion of our financial situation (which is in good shape), updating some non-profit status tax issues, coordinating our meeting with AAEA, and looking at our bylaws. ## WAEA Presidential Candidates (choose one)

**Donald M. McLeod – Associate Professor, University of Wyoming**



*Background:* Graduated from Oregon State University in Natural Resource and Environmental Economics 1994. Course preps include micro principles; environment and society; farm and ranch management; water resource economics; advanced natural resource economics; graduate research methodology; and natural resource planning economics. 14 year instructor for Haub School of Environment and Natural Resources graduate/undergraduate Capstone Course; and 10 year instructor for Agricultural and Applied Economics undergraduate Capstone course. President W-2133 Regional Research Committee (2004); and Current WAEA Western Economics Forum Editor (2008-10).

### *WAEA Vision Statement*

The president of the WAEA should strive to enhance the relevance of WAEA in a variety of traditional and newly emerging areas of research and policy (i.e., Economics of Wildlife; Multi-functionality of Rural Lands; Niche Markets and Specialty Products; Risk Mitigation Strategies; Public Lands Issues; Pan Pacific and Western Hemisphere Trade Issues; Rural Well Being; Tourism and Extractive Industries).

The annual set of conference presentations as well as the JARE and WEF journals could be organized around special topic specific volumes-sessions that extend beyond, but do not omit, traditional areas. This purpose is also better served through designation of Outreach and Extension Educator Sessions in addition to student instruction sessions-volumes.

The president has and should continue to develop partnerships beyond current liaisons to include joint work with, or some sort of participation by, AERE, Regional Research Committees, Western Governors, and the WRDC. MS student presentations/memberships should continue to be encouraged as part of the annual meetings. I would like to see novel amenity-rich Meeting Sites.

**Russell Tronstad – Professor, University of Arizona**



*Background:* Russell Tronstad is a University Distinguished Outreach Professor in the Department of Agricultural and Resource Economics at the University of Arizona. He received his B.S. and M.S. degrees from Montana State University and Ph.D. from the University of Illinois. Dr. Tronstad has served as WAEA Director (1999-2001), Co-Editor of *JARE* (2000-2003), WAEA Vice-President (2007-2008), reviewer and contributor to both the *Journal of Agricultural and Resource Economics* and *Western Economics Forum*, and regular presenter of selected papers at annual meetings. He has received recognition from the WAEA for the Outstanding Extension Project Award (1997, 2005 and 2006).

### *WAEA Vision Statement*

I have enjoyed many benefits as a member of the WAEA for almost 20 years and am honored and excited about the opportunity to help continue and enhance the ongoing activities of the WAEA. The opportunity to learn and interact with other agricultural economists interested in western problems through WAEA's annual meetings and publication outlets of *JARE* and *WEF* has increased our understanding of many issues in the western United States and Canada. If elected, I will work to preserve and enhance these activities for our Association.

I believe the WAEA should focus on our two most successful activities, *JARE* and our annual summer meeting. *JARE* is recognized as one of the top agricultural and resource economics journals and our Association should continue to direct resources and follow policies that help bolster *JARE*'s reputation. Financial resources devoted to preserving and enhancing *JARE* should be at the top of our Association's budget. A key responsibility of the president is organizing the program for our annual summer meeting. These meetings should be held at attractive locations in the West, focus on economic issues facing the West, and attract solid participation from both Canada and the United States. Increasing the presence of senior members at our annual meetings and their interactions with students is an objective I will work to

achieve. I believe we should continue to provide a limited number of graduate student travel scholarships to the meetings to encourage student participation.

Writing our newsletters in a timely manner and conducting business activities of the Association are other important duties of the President. With regards to the current financial situation of the Association, the WAEA should explore avenues for increasing revenues, including the promotion of endowment funds, membership for all submitting authors of selected papers and *JARE* articles, and even increasing our membership fee. If elected President, I will work towards growing our long-term membership and improving the financial soundness of our Association. I will prioritize my time to ensure that our annual meetings encourage diverse member and student participation, grow long-term loyalty, and return goodwill to our Association.

## **WAEA Vice-Presidential Candidates (choose one)**

### **Christopher T. Bastian – Assistant Professor, University of Wyoming**



*Background:* Chris Bastian received Ph.D. in Agricultural and Resource Economics from Colorado State University. He has received the Outstanding Extension Award from the American Agricultural Economics Association twice (1997 & 2007) and three regional awards in extension from the Western Agricultural Economics Association (1997, 2005, 2006). Bastian's service to the WAEA includes: Director (2007-2009); Outstanding Published Research Award Committee (2007); Selected Paper Referee (2008); Extension Award Review Committee (2008); Graduate Student Travel Scholarship Award Committee (2009 Co-chair with Jayson Lusk); *JARE* reviewer; *JARE* contributor; and, substitute council representative from UW.

#### *WAEA Vision Statement*

The WAEA is my favorite professional organization for agricultural economists. I have found the professional development opportunities at WAEA meetings to be rewarding and intellectually stimulating. I especially enjoy the opportunity to learn from and interact with other agricultural economists interested in Western issues. High quality meetings and high quality publications such as the *JARE* and *WEF* are at the core of what the Association does and should continue to offer in terms of professional development for its members and opportunities to communicate scholarly efforts to other applied economists and clientele being served by its members. Moreover, as the Association's niche is Western issues, the Association also must work to maintain that niche even as we collaborate with other associations and organizations. For example, in the recent past, there have been pre-conference workshops related to risk management education. I believe the WAEA should continue to develop such offerings as is feasible. Part of the Vice President's responsibility at that time will be to coordinate efforts with the Canadian Association to solicit paper submissions, organize reviews, and from the chosen papers develop a meeting program that will offer professional development opportunities to members of both associations. If elected, I will take these responsibilities seriously and conduct myself in accordance with these responsibilities and my vision for the Association.

### **Hayley H. Chouinard – Associate Professor, Washington State University**



*Background:* Hayley H. Chouinard received her Ph.D. in Agricultural and Resource Economics from the University of California, Berkeley. Hayley's service to WAEA include Council Director (2006-2008) and Council Member (2008-present); Outstanding Master's Thesis Award Committee (2007 and 2008); Distinguished Scholar Award Committee (2007 and 2008); Graduate Travel Award Committee (Co-Chair 2008); Outstanding Published Research Award Committee (2009); Reviewer for the *Journal of Agricultural and Resource Economics*; and moderator, reviewer, author and presenter for selected papers at the annual meetings since 2003.

#### *WAEA Vision Statement*

I have found my membership in the WAEA a very valuable resource for scholarly engagement and opportunity. My main focus as a member of the WAEA leadership would be to maintain and enhance the characteristics of the Association that provide such great value; the journals

and annual meetings. ### Catherine Keske – Assistant Professor, Colorado State University



*Background:* Catherine Keske is an Assistant Professor of Agricultural and Resource Economics and Associate Director of the Institute for Livestock and the Environment in the Department of Soil and Crop Sciences at Colorado State University. She earned a M.S. degree in Mineral Economics from the Colorado School of Mines and a Ph.D. in Agricultural and Resource Economics from Colorado State University. She also earned a M.S. in Hearing and Speech Sciences from Vanderbilt University. She is also an Adjunct Professor at the Denver University Sturm College of Law. She is a former board member of the Mountain Area Land Trust, a current board member of Teens on Farms, and a Center Director for the Colorado Council for Economic Education.

#### *WAEA Vision Statement*

With JARE and WEF, the WAEA has successfully provided its members with a balance of high quality academic journals that also serve as an outlet for regional topics germane to the western United States. The high attendance and paper submission rate for the annual WAEA meetings also indicate a thriving organization that is fulfilling the interests of its members. However, as eloquently articulated by Dr. Boland at the 2009 meetings in Kauai, the discipline of agricultural and resource economics is at crossroads. As a WAEA Director, I intend to work with the organization to bridge past leadership and with young professional leaders to ensure continuity for the organization's future. As part of this vision, I would like to help cultivate relationships with graduate student education programs and young professionals. *Background:* Kathleen Painter earned her Ph.D. in Agricultural Economics at Washington State University in 1992. She worked as a 1) Peace Corps volunteer in the Philippines, 2) bank lender, 3) Extension agent, and 4) farmer on a large commercial potato, onion, and asparagus farm in the Columbia Basin, 5) manager of an internet-based business selling supplies to handspinners, including fleece from her flock, 6) analyst for Center for Sustaining Agriculture, and 7) a permanent position at the University of Idaho in January 2009.

#### *WAEA Vision Statement*

If elected, I would work to increase communication among members, encouraging input and feedback on the association's activities, using quick new online techniques such as the SurveyMonkey. It amazes me to see the level of continued participation in this association by professionals who have moved out of the western region—which attests to the quality and vigor of this organization. Since only a small number of presenters actually write papers for the meetings, I think we should produce a webpage for each annual meeting with electronic versions of the presentations (pdf versions of all

powerpoints and possibly some videos of presentations by keynote speakers). This type of documentation would be an excellent resource for participants while vastly increasing the audience for these presentations. Our current journals provide an excellent outlet for publishing written papers, but a website with electronic media would update our image, provide current research findings on recent topics, and encourage idea-sharing among our members. The meetings provide a unique opportunity for students, encouraging them in their research endeavors while possibly enticing them to further their education or join regional faculties. Recent meetings have had an excellent mix of free time and scheduled events, allowing for time to catch up with friends as well as providing structured events for meeting new people. I like the family-friendly orientation in lovely areas of this large region and, with the help of fellow members, would try to find outstanding new venues for our annual meeting places.

### **Hikaru Hanawa Peterson - Associate Professor, Kansas State University**



The new editorial team has been managing new submissions since April of this year. We look forward to receiving high-quality submissions from our members.
